LEVEL 1 (Caution)	Caution required regarding infections.	Classes are held on campus (face-to-face) and remotely, with appropriate precautions being taken to prevent the spread of infections. Permissions are required for any activities off campus (limited to Japan, no overseas travel). However, activities where the Three C's are unavoidable, such as training camp and journeying as a group on a bus, etc. shall not be permitted.	Students are allowed on campus, with appropriate precautions being taken to prevent the spread of infections. However, there may be some limitations as to how certain facilities are used. LEVEL 2 (Exercise Increased Caution)	No State of Emergency has been declared, but increased caution is required regarding the spread of infection. Permissions are required for any activities off campus (limited to Japan, no overseas travel). However, activities where the Three C's are unavoidable, such as training camp and journeying as a group on a bus, etc. shall not be permitted.	Students are allowed on campus, with appropriate precautions being taken to prevent the spread of infections. However, there may be some limitations as to how certain facilities are used.	Extracurricular activities can be conducted, but they shall require permissions, with appropriate precautions being taken to prevent the spread of infections. LEVEL 3 (Heightened Precautions)	In the event that Kyoto Prefecture has been designated as a Prefecture under Special Precautions.	Only remote classes can be conducted.	No students allowed on campus. LEVEL 4 (State of Emergency)	In the event that the national government declares a countrywide State of Emergency.	Only remote classes can be conducted.	No students allowed on campus.	All extracurricular activities are suspended.	Closed for business.	Only persons involved in essential/lifeline work for KUFS allowed on campus.	No external parties are permitted to use the KUFS facilities.
