※以下に該当する人は出願の対象外です。

- ・経済的に恵まれていると認められる人
- ・授業出席状況や学業成績により、修学意欲がないと認められる人
- ・2020 年度の進級判定で「留年」となった人
- ・2021 年度に他の奨学金を受給している人
- ・2021 年度入学者で入学金を免除された人

### 減額率

当該年度の授業料の 30%を減額

- 7.在日扶養者もしくは世帯主の市民税・県民税課税証明書【所得証明書】（該当者のみ）

## **【Grant-type】 Tuition Reduction for Privately Financed International Students**

---

For privately financed international students enthusiastic about learning and who find it difficult to pay school expenses due to financial reasons

### **Eligibility**

---

Full-time undergraduate/graduate course students having the status of residence “Student” and who are privately financed

※GPA of 2.5 or higher (Graduation Requirements) is required through the spring semester of AY 2021.

**\* Those listed below are not eligible for this system.**

- Students who are considered to be economically advantaged
- Students who are considered not to be enthusiastic about learning, judging from their attendance record and academic performance
- Students who were not allowed to move on to the next year at the end of AY 2020
- Students receiving a scholarship in AY 2021
- Students who enrolled in AY 2021 and are exempted from admission fees

### **Reduction rates**

---

Tuition for the relevant year will be reduced by 30%

### **Documents to be submitted**

---

1. Application in designated form
2. Transcript (Academic Report)
3. Application for the postponement of tuition payment for the fall semester (It will be available for students to pick up at the Division of Student Affairs from September 20th, 2021)
4. Copy of your residence card (both sides)
5. Copy of the lease agreement of your apartment house, etc.
6. Copy of document(s) indicating your income from a part-time job(s) during the past three months (if applicable)
7. Taxation certificate for municipal/prefectural resident tax [income certificate] of your financial supporter living in Japan or head of household (if applicable)
